GIBA TOLL PASS TERMS AND CONDITIONS I am applying for a Gasparilla Island Bridge Authority Discount Toll Card. I certify that the information provided herein is accurate to the best of my knowledge. Once money has been put into my account I understand and accept that no credits or refunds will be issued under any circumstances. It is my responsibility to report lost or stolen cards and/or stolen or sold vehicles with the window decal to the Gasparilla Island Bridge Authority as soon as possible. I understand that any account unused for a period of one (1) year will be automatically cancelled and any money remaining in the account will be forfeited. The Gasparilla Island Bridge Authority reserves the right to change, delete, limit, or modify at any time the terms of this agreement without advance notice. The Gasparilla Island Bridge Authority (GIBA) is not responsible for lost or stolen passes. The user of the pass agrees to abide by all GIBA bridge and causeway rules and regulations. Failure to comply may result in cancellation and loss of discount privileges. Fraudulent use of stolen or lost passes will result in criminal prosecution of the offender and loss of discount privileges. This is not a credit card. All cards and decals remain the property of the Gasparilla Island Bridge Authority and if requested, I agree to return to the Gasparilla Island Bridge Authority office any and all decals/cards. By signing I verify I have read and understand these disclosures.

WHAT IS THE DISCOUNT CARD PROGRAM?

The Gasparilla Island Bridge Authority (GIBA) Toll Discount Card is a prepaid user account. The toll card offers the account holder better savings and faster service at the toll plaza, than paying by cash. Tolls are paid by scanning the bar code sticker or RFID sticker. The round trip fee is then deducted from your account balance. The toll pass is offered at a discounted savings. That means you pay \$3.25 per trip (with a pass) compared to \$5.00 (with cash). Commercial accounts (trucks and trailers) may also open an account, but the commercial vehicles are not discounted.

ACCOUNT PAYMENT OPTIONS

Automatic Renewal – Your account will automatically be replenished (with either your Visa or Mastercard) by the amount you select. The minimum prepayment amount is \$97.50. When your account balance reaches a low balance of 4 trips your credit card is charged for your renewal amount. (Note: You may set your "Low Balance" to a higher number than 4 trips)

Cash Prepaid – You may open an account with a cash, check, or credit card prepayment. If you allow your account to run out your card will be denied. To replenish your account you may get an envelope from the tollbooth attendant (for check payments only), or simply visit our administration building to replenish your account.

HOW LONG IS THE DISCOUNT CARD GOOD FOR?

The discount card is designed as a convenience for "frequent" users. Any balance on your account remains accessible as long as your account is active. Your account will remain active as long as your card/decal is used at least once a year from the last time you used it. If you allow your account to stay inactive for more than 12 consecutive months, your account will be closed and any balance is forfeited.

FEES for TOLL CARDS or DECALS

\$5.00 – For each bar coded GIBA Toll Card or to replace a lost or damaged card.

\$5.00 - For each bar coded GIBA Toll Decal

\$10.00 – For each RFID hang tag or sticker

GIBA VEHICLE TOLL RATES

GIBA Discount Card (MINIMUM OF \$97.50)

-\$3.25 per trip for a two axle

Commercial Trucks

- \$9.00 for a two axle truck

- \$4.50 for each additional axle

GIBA ANNUAL PASS

Vehicle Eligibility: Only the following types of 2-axle vehicles are Annual Pass eligible
Cars, Vans and Pickup trucks - only.

NOTE: Dual wheel pickups & Commercial trucks are NOT eligible for an Annual Pass.

The Annual Pass allows the user to pay one **\$ 650.00 fee**, in advance, for 12 months of use. This fee allows the vehicle driver to make unlimited round trips for the one-year term.

The Annual Pass requires that a GIBA DECAL be purchased (Cost \$5.00). The Decal must then must be permanently attached to ONE vehicle only.
